Heubach supports customers by helping them to choose colorants (dyes, pigments and pigment preparations) that meets the requirements of the Nordic Ecolabel »Nordic Swan« and the EU Ecolabel.

Heubach's portfolio of recommended dyes, pigments and pigment preparations for the use in products bearing eco-labels are suitable for a broad variety of applications including professional cleaners, as well as cleaning products found in daily life – from laundry and dishwasher detergents, to soaps and cosmetic products.

The ingredient formulations for each individual cleaning product group must fulfill certain criteria regarding safety towards health or the environment, e.g.:

- Ban or limitations on certain hazardous substances
- Aquatic toxicity
- Biodegradability

For some cleaning product categories, specific criteria for colorants are defined, such as approval for use in foodstuffs or having no bio-accumulation potential.

Heubach's colorants suitable for the use in products bearing eco-labels meet also the requirements for not being bio-accumulating. Assessment of the logK_{ow} (partition coefficient oil/water) values indicates that all the colorants meet the lowest threshold defined in the corresponding Nordic Ecolabel and EU Ecolabel product group guidelines.
